

UPON HEARING Robert Glancy QC one of Her Majesty's Counsel, on behalf of the Claimant and Ed Bishop QC one of Her Majesty's Counsel, on behalf of the Defendant

UPON terms of settlement having been agreed between the parties, subject to the approval of the Court

AND UPON there being no objection from any member of the public or press

AND UPON the court being satisfied that an Order in the terms of paragraphs 1 to 4 below is necessary to protect the interests of the Claimant and his family and that there is no countervailing public interest in disclosure

## IT IS ORDERED that:-

- The Claimant and his Litigation Friend shall hereinafter be referred to in these proceedings respectively as BNM and JKL;
- Pursuant to CPR Rule 39.2(4) there shall not be disclosed in any report
  of the proceedings the name or address of the Claimant or his Litigation
  Friend or any details leading to the identification of the Claimant or his
  Litigation Friend and the Claimant and his Litigation Friend, if referred
  to, shall only be referred to as BNM and JKL;
- 3. Pursuant to CPR Rule 5.4C a person who is not a party to the proceedings may obtain a copy of a statement of case, judgment or order from the court records only if the statement of case, judgment or order has been anonymised such that: (a) the Claimant and his Litigation Friend are referred to in those documents only as BNM and JKL and (b) that any reference to the names of the Claimant and his Litigation Friend or any details leading to their identification be deleted from those documents;
- 4. Liberty to any party to apply to discharge or vary this Order having given seven days prior written notice to the solicitors for the Claimant and for the Defendant.
- 5. Costs in the case.
