	<p><b>REGULATION 28 REPORT TO PREVENT FUTURE DEATHS</b></p> <p><b>THIS REPORT IS BEING SENT TO:</b></p> <p><b>1. Birmingham City Council Highways department</b> <b>2. West Midlands Police Road Traffic Division</b></p>
1	<p><b>CORONER</b></p> <p>I am Louise Hunt, Senior Coroner, for the coroner area of Birmingham and Solihull</p>
2	<p><b>CORONER'S LEGAL POWERS</b></p> <p>I make this report under paragraph 7, Schedule 5, of the Coroners and Justice Act 2009 and regulations 28 and 29 of the Coroners (Investigations) Regulations 2013.</p>
3	<p><b>INVESTIGATION and INQUEST</b></p> <p>On 11 November 2013 I commenced an investigation into the death of Saleh Ali Dalie. The investigation concluded at the end of the inquest on 4th March 2014. The conclusion of the inquest was road traffic collision.</p>
4	<p><b>CIRCUMSTANCES OF THE DEATH</b></p> <p>The deceased came out of his house on Kyotts Lake Road and went to cross the road to attend his local mosque. He entered the road between parked cars and was he was hit by a van. He was taken to the Queen Elizabeth Hospital where he later died from his injuries.</p>
5	<p><b><u>CORONER'S CONCERNS</u></b></p> <p>During the course of the inquest the evidence revealed matters giving rise to concern. In my opinion there is a risk that future deaths will occur unless action is taken. In the circumstances it is my statutory duty to report to you.</p> <p>The <b>MATTERS OF CONCERN</b> are as follows. –</p> <p>(1) There have been several incidents and 2 fatalities on this road. Residents have campaigned for road calming measures and parking restrictions and appropriate crossing measures which have not been introduced. I am concerned about the safety of this road given it is a residential area.</p>
6	<p><b>ACTION SHOULD BE TAKEN</b></p> <p>In my opinion action should be taken to prevent future deaths and I believe your organisation have the power to take such action.</p>
7	<p><b>YOUR RESPONSE</b></p> <p>You are under a duty to respond to this report within 56 days of the date of this report, namely by 6<sup>th</sup> May 2014. I, the coroner, may extend the period.</p> <p>Your response must contain details of action taken or proposed to be taken, setting out</p>

	the timetable for action. Otherwise you must explain why no action is proposed.
8	<p><b>COPIES and PUBLICATION</b></p> <p>I have sent a copy of my report to the Chief Coroner and to the following Interested Persons Mr Dalie's family.</p> <p>I am also under a duty to send the Chief Coroner a copy of your response.</p> <p>The Chief Coroner may publish either or both in a complete or redacted or summary form. He may send a copy of this report to any person who he believes may find it useful or of interest. You may make representations to me, the coroner, at the time of your response, about the release or the publication of your response by the Chief Coroner.</p>
