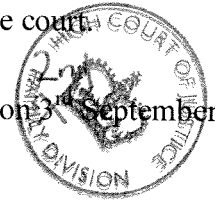
AND UPON the Respondents not having notice of this application, their whereabouts being currently unknown.

IT IS ORDERED THAT:

1. The Child Ashya King (dob 05.07.09) shall be and remain ward of this Honourable Court during his minority or until such time as this order is varied.
2. The court orders that :
 - (a) the respondents shall immediately present the child for medical treatment at the nearest hospital forthwith.

- (b) the respondents shall at the appropriate time, to be determined by the medical professionals at his place of treatment, return the child to the jurisdiction of the High Court of England and Wales.
 - (c) the respondents shall co-operate with the medical professionals dealing with the treatment of the child in respect of any advice or treatment received from those medical professionals.
 - (d) upon the child being delivered to the nearest hospital, the respondents are forbidden to remove him therefrom without the permission of the court.
3. The applicant shall file a statement in support of its application by 4pm on 3rd September 2014.
 4. The applicant shall have permission to disclose the papers in this matter to the authorities in France, Spain, Germany, the Netherlands and the Czech Republic, or any other such country where the child is believed to be present, through the Central Authority of such countries.
 5. This matter shall return for further directions at 10.30am on 3 September 2014.
