1. On the 13th July 2015 this court committed the following named person to prison

ASHLEY DICKENSON

- 2. In relation to orders dated
- 9th February 2015 and 17th February 2015.
- 3. which provided that the Respondent must not:
- i) use or threaten violence against the Applicant GEMMA CAPLE, and must not instruct, encourage or in any other way suggest that any other person do so.
- ii) use threatening or abusive language in any communication with the Applicant GEMMA CAPLE
- ii) not damage, attempt to damage or threaten to damage any property owned by or in the possession of the Applicant GEMMA CAPLE and must not instruct, encourage or in any other way suggest that any other person do so.
- iii) not disclose, disseminate or publish any information about these proceedings concerning the Applicant GEMMA CAPLE or the children of the family, whether by print, electronic form, or on the world wide web and must not instruct, encourage or in any other way suggest that any other person do so
- iv) (having left 17 Monmouth Street, Derby DE21 6BD) return to, or attempt to return to, enter or come within 50 metres of the aforementioned property.
- 4. The court found that he had disobeyed/breached that order by:
- i) Contacting the Applicant GEMMA CAPLE on a date in February 2015 after 17 February 2015, being verbally abusive and threatening to take a TV from 17 Monmouth Street
- ii) Entering 17 Monmouth Street on 12 March 2015, and subjecting the Applicant GEMMA CAPLE to verbal abuse and threats.
- iii) Entering 17 Monmouth Street on a date after 12 March 2015 but before the end of March 2015.
- iv) Encouraging the parties' minor son to take the Applicant GEMMA CAPLE's car keys and arranging for the car to be taken by an associate of his, without the Applicant's consent
- v) During the last week of March 2015, making a series of verbally abusive and threatening phone calls to Applicant GEMMA CAPLE.
- vi) Placing information (some of it of an abusive and offensive nature) on Facebook relating to the Applicant GEMMA CAPLE and the children
- vii) Subjecting the Applicant GEMMA CAPLE to verbal abuse and violence at school on 28 April 2015.

- viii) Subjecting the Applicant GEMMA CAPLE to verbal abuse and violence at school on 14 May 2015.
- ix) Coming within 50m of 17 Monmouth Street on 25 May 2015 and subjected the Applicant GEMMA CAPLE to verbal abuse
- 5. and imposed the following sentence(s) for those breach(es) breach
- i) of injunction and occupation order Sentence
- i) 14 days imprisonment
- ii) 26 weeks imprisonment
- iii) 26 weeks imprisonment
- iv) 18 weeks imprisonment
- v) 8 weeks imprisonment
- vi) 18 weeks imprisonment
- vii) 18 weeks imprisonment
- viii) 26 weeks imprisonment

To run concurrently

6. Accordingly it was ordered that ASHLEY DICKENSON be committed for contempt to Her Majesty's Prison for a (total) period of 26 WEEKS or until lawfully discharged if sooner) and that time spent on remand in Custody should count towards sentence.
