1. On 13th August 2015 this court committed the following named person to prison

2. In relation to an order dated

16 SEPTEMBER 2014 VARIED ON 9TH MARCH 2015

3. which provided that the Defendant should not

- i) **Be in any public place between the hours of 21:00 and 06:00 within the city of Preston.**
- ii) **Remain in an exclusion zone defined in the order and shown on a map attached to the order.**
- iii) **Possess equipment for use in the distribution of any Class A or B drugs such as snap bags.**
- iv) **Use or threaten to use violence against any person.**
- v) **Engage in any abusive threatening or intimidating conduct**
- vi) **Own or have with him more than one mobile telephone.**

4. the court found that following admissions made he had breached that order by

- i) 1. Being in a public place between the hours of 21:00 and 06:00 contrary to prohibition 1 of the order dated 16/09/14, on 3/2/15
- 2. Being in the exclusion zone contrary to prohibition 2 of the order dated 16/09/14, on 10/2/15
- 3. Being in the exclusion zone contrary to prohibition 2 of the order dated 16/09/14, on 11/2/15
- 4. Being in a public place between the hours of 21:00 and 06:00 contrary to prohibition 1 of the order dated 16/09/14, on 9/4/15 and Being in the exclusion zone contrary to prohibition 2 of the order dated 16/09/14, on 9/4/15.
- 5. Use or threatening to use violence against and person or property on 10/4/15.
- 6. Being in a public place between the hours of 21:00 and 06:00 contrary to prohibition 1 of the order dated 16/09/14, on 25/4/15.
- 7. Being in possession of equipment for use in the distribution of any Class A or B drugs including snap bags

8. Engaging abusive, threatening or intimidating conduct on the 25/4/15.
9. Owning or having with him more than one mobile telephone on 25/04/15.

5. and imposed the following sentence for that breach

1. Being in a public place between the hours of 21:00 and 06:00 contrary to prohibition 1 of the order dated 16/09/14, on 3/2/15	1 . 14 days immediate custodial sentence
2. Being in the exclusion zone contrary to prohibition 2 of the order dated 16/09/14, on 10/2/15	2. 14 days immediate custodial sentence
3. Being in the exclusion zone contrary to prohibition 2 of the order dated 16/09/14, on 11/2/15	3. 14 days immediate custodial sentence to be served concurrently with 2 above.
4. Being in a public place between the hours of 21:00 and 06:00 contrary to prohibition 1 of the order dated 16/09/14, on 9/4/15 and Being in the exclusion zone contrary to prohibition 2 of the order dated 16/09/14, on 9/4/15.	4. 14 days immediate custodial sentence in respect of each breach to be served concurrently with 1 and 2 above.
5. Use or threatening to use violence against and person or property on 10/4/15.	5. 56 days immediate custodial sentence
6. Being in a public place between the hours of 21:00 and 06:00 contrary to prohibition 1 of the order dated 16/09/14, on 25/4/15.	6. 14 days immediate custodial sentence to be served concurrently with 1 above.
7. Being in possession of equipment for use in the distribution of any Class A or B drugs including snap bags	7. 28 days immediate custodial sentence.
8. Engaging abusive, threatening or intimidating conduct on the 25/4/15.	8. 56 days immediate custodial sentence
9. Owning or having with him more than one mobile telephone on 25/04/15	9. 28 days immediate custodial sentence to be served concurrently with 7 above

6. Accordingly it was ordered that⁽²⁾ **JORDAN LEE MURRAY**

be committed for contempt to Her Majesty's Prison at⁽³⁾ **Preston** for a total period of 148 **days** or until lawfully discharged if sooner
