1. On the 25 of 08/2015 this court committed the following named person to prison

Stuart Hurst

2. In relation to an order dated

13 March 2015

3. which provided that the Respondent/ Defendant should not [set out relevant paras of the order]

i) Not to use or threaten violence towards Peter Yeates of Flat 23 Langton Court, Moss Lane, Platt Bridge, WN2 3UH.

ii) Not to play excessively loud music, shout or swear loudly so as to cause a nuisance or annoyance to any person residing in, visiting or lawfully in the vicinity of Langton Court, Moss Lane, Platt Bridge, WN2 3UH

ii) Not to engage in or threaten to engage in conduct which is capable of causing a nuisance or annoyance to any person residing in, visiting or otherwise engaging in lawful activity in or in the neighbourhood of Langton Court, Moss Lane, Platt Bridge, WN2 3UH.

4. the court found that [following admissions made he had disobeyed/breached that order by

a. On the 08 April 2015 from 10.00pm until 11.00pm the Defendant caused a nuisance to Peter Yeates by shouting abuse "you fucking cunt, bastard, you pile of shit, why don't you fuck off".

This is a breach of clauses 1 and 4 of the Undertaking.

b. On the 09 April 2015 from 10.45pm until midnight the Defendant caused a nuisance by shouting from inside his flat "You fucking Cunt Peter, why don't you fuck off, nobody wants you here".

This is a breach of clause 4 of the Undertaking.

c. On the 19 April 2015 from 11.00pm until midnight the Defendant caused a nuisance by shouting "you fucking cunt, just fuck off". He repeated this sentence over and over again. This is a breach of clause 4 of the undertaking.

- d. On 30 April 2015 at 6:40pm the Defendant caused a nuisance by shouting to people in the vicinity of Langton Court “why don’t you all fuck off, we don’t want you round here”. This is a breach of clause 4 of the Undertaking.
- e. On 03 May 2015 from 10.00pm until 10.30pm the Defendant caused a nuisance by playing loud music from inside his flat.
This is a breach of clause 3 of the Undertaking.
- f. On the 08 May 2015 at 6.30pm the Defendant caused a nuisance and threatened violence to Peter Yeates by shouting “I’m going to fucking batter you, you fucking cunt”. This is a breach of clauses 1 and 4 of the undertaking.
- g. On the 14 May 2015 from 10.00pm until 11.00pm the Defendant caused a nuisance and threatened violence to Peter Yeates by shouting “you cunt, I’m going to kill you”. This is a breach of clauses 1 and 4 on the Undertaking
- h. On the 17 May 2015 from 10.00pm until 11.00pm the Defendant caused a nuisance and threatened violence to Peter Yeates by shouting “I will fucking kill you”. The Defendant also banged on the floor.
This is a breach of clauses 1 and 4 of the Undertaking.

5. and imposed the following sentence(s) for those breach(es)
