3) Using abusive or insulting or threatening or racist behaviour against any person with a right to reside in or occupy or visit housing in the locality of 40 Eyre Street, Hulme, Manchester, M15 6HD or to a person engaged in a lawful activity in the neighbourhood of 40 Eyre Street, Hulme, Manchester, M15 6HD

At 22.41 hours on 1st December 2015, the Respondent was present inside the exclusion area in Hulme, Manchester and in breach of clause 5 of the Injunction Order (with Power of Arrest) personally served upon the Respondent on 7th October 2015. The Respondent was specifically detained by Police Officers inside the property of 40 Eyre Street, Hulme, Manchester.

ii) 2. From 22.41 hours on 1st December 2015, the Respondent engaged in loud arguing and repeatedly used foul and abusive language whilst inside the property of 40 Eyre Street, Hulme, Manchester specifically addressing PC Giannasi using the words "Fuck off."
