1. On the 14th of September 2015 this court committed the following named person to prison

Holly Davies

2. In relation to an order dated

9<sup>th</sup> July 2015

3. which provided that the Respondent/ Defendant should not

- i) **approach Andrew Stephen Morris or any member of or visitor to his household**
- ii) **use foul and abusive language or communication towards Andrew Stephen Morris or any member of or visitor to his household**
- iii) **use threatening or abusive language towards Andrew Stephen Morris or any member of or visitor to his household**
- iv) **engage in behaviour or use words which cause or are capable of causing nuisance or annoyance to Andrew Stephen Morris or any member of or visitor to his household**
- v) **enter the area edged red on the plan annexed to the order (as amended on 13<sup>th</sup> July 2015.**

4. The court found that she had disobeyed/breached that order by

- i) **shouting abuse at Mr Morris at 1545 hours on 10 July 2015**
- ii) **entering the area edged red at 1735 hours on 12 July 2015**
- iii) **throwing a burnt copy of the order onto Mr Morris' property and at or about 2050 on 12 July 2015 punching him in the face**
- iv) **entering the area edged red between about 1730 and 1830 on 19 July 2015 and threatening to punch Mr Morris' father**
- v) **being in the area edged red at about 1215 hours on 5 August 2015**
- vi) **being in the said area again at 2030 hours on the same date**
- vii) **whilst in the area edged red on 5 August 2015 shouted abuse at Mr Morris and his father, calling them "perverts"**
- viii) **being inside the area edged red on 22 August 2015**
- ix) **being inside the area edged red on 24 August 2015**
- x) **approaching Mr Morris at about 2120 hours and swearing at him on 24 August**
- xi) **posting a photograph of Mr Morris on Facebook alleging him to be a "paedo" (sic)**
- xii) **posting a further message on Facebook telling readers to "keep [their] children away fro this gay pedo (sic) Andrew Morris"**

5. and imposed the following sentences for those breaches

breach	Sentence
i) abuse on 10 July	i) 14 days imprisonment
ii) entering area 12 July	ii) 14 days imprisonment 28 days imprisonment
iii) throwing burnt injunction and assaulting Morris on 12 July	iii) 3 months imprisonment
iv) entering area and threat to Morris senior on 19 July	iv) 28 days imprisonment
v) being in area edged red on 5 August	v) 28 days imprisonment
vi) ditto	vii) 28 days imprisonment
vii) shouting abuse at Morris on 5 August	viii) No penalty imposed
viii) being in area edged red on 22 August	ix) No penalty imposed
ix) ditto on 24 August	x) 28 days imprisonment
x) swearing at Morris at a separate location on 24 August	xi) 4 months imprisonment
xi) posting an abusive Facebook message on 28 August 2015	xii) 4 months imprisonment
xii) ditto on 28 August	
	All sentences to run concurrently.

6. Accordingly it was ordered that Holly Davies be committed for contempt to prison for a (total) period of 4 (four) months

The order is suspended until 14th March 2017 and will not be put into force if during that time Holly Davies complies with the following terms:
