1. On the 25 of July 2016 this court committed the following named person to prison

2. In relation to an order dated

**30<sup>th</sup> November 2015**

3. which provided that the Respondent/ Defendant should not [set out relevant paras of the order]

**i) Allow Mrs Eve Preston to reside at the premises (15 Stamford Road, Blacon, Chester, CH1 5DG or visit the premises after 4pm 11<sup>th</sup> December 2015**

4. the court found that [following admissions made] (s)he had disobeyed/breached that order by

**i) On Thursday 21<sup>st</sup> July 2016 between approximately 23:00 Hours and 23:15 Hours the first Defendant was present inside the property 15 Stamford Road, Blacon, together with the second Defendant.**

5. and imposed the following sentence(s) for those breach(es)

**i) On Thursday 21<sup>st</sup> July 2016 between approximately 23:00 Hours and 23:15 Hours the first Defendant was present inside the property 15 Stamford Road, Blacon, together with the second Defendant.**

Sentence

**i) 14 days imprisonment suspended until 24<sup>th</sup> January 2017 on the condition that he comply with the injunction dated 30<sup>th</sup> November 2015**

6. Accordingly it was ordered that<sup>(2)</sup>

be committed for contempt to Her Majesty's Prison at<sup>(3)</sup> for a (total) period of or until lawfully discharged if sooner, [and that a warrant of arrest and committal be issued forthwith].

**OR**

David Rodgers be committed for contempt to prison for a (total) period of 14 days  
The order is suspended until **24<sup>th</sup> January 2017** and will not be put into force if during that Time David Rodgers complies with the following terms:

1. Mr David Rogers **must by 4pm on 14th December 2015** clear the garden of 15 Stamford Road, Blacon, Chester, CH1 5DG ("the Premises") of all rubbish, scrap metal, oil barrels, and litter.
2. Mr David Rogers **must by 4pm on 14th December 2015** clear the Premises of all clutter either by his own efforts or by allowing the Claimant, Sanctuary Housing Association's, agents to undertake the work.
3. Mr David Rogers **must by 4pm on 14th December 2015** clean the Premises to the satisfaction of Sanctuary Housing Association either by his own efforts or by allowing Sanctuary Housing Association's agents to undertake the work.
4. Mr David Rogers **must by 4pm on 14th December 2015** arrange for the repair of the front door and window and any other broken doors or windows in the Premises either by his own efforts or by allowing Sanctuary Housing Association's agents to undertake the work.
5. Mr David Rogers **must** allow Sanctuary Housing Association access to the Premises and garden upon notice of not less than 24 hours.
6. Mr David Rogers **is forbidden (whether by himself or by instructing or encouraging or permitting any other person) from** allowing Miss Eve Preston to reside at the Premises (15 Stamford Road, Blacon, Chester, CH1 5DG) or visit the Premises after 4:00 p.m 11 December 2015.
7. Mr David Rogers **is forbidden (whether by himself or by instructing or encouraging or permitting any other person) from** storing barrels of oil in the garden of the Premises.
8. Mr David Rogers **is forbidden (whether by himself or by instructing or encouraging or permitting any other person) from** starting fires in the garden of the Premises or in the vicinity of the Premises.
9. Mr David Rogers **is forbidden (whether by himself or by instructing or encouraging or permitting any other person) from** damaging the shrubs, trees, shed and grass in the garden of the Premises by fire or any other means.

10. Mr David Rogers **is forbidden (whether by himself or by instructing or encouraging or permitting any other person) from** engaging in conduct which is likely to cause harassment, alarm or distress to any persons in residence or visiting Stamford Road, Blacon, Chester.

11. Mr David Rogers **is forbidden (whether by himself or by instructing or encouraging or permitting any other person) from** engaging in conduct capable of causing annoyance or nuisance to any resident or visitor to Stamford Road, Blacon, Chester, or the locality.

**AND IT IS FURTHER ORDERED THAT:**
