3. Which provided that the Defendant should not

i) Miss Eve Preston **must** vacate the Premises, 15 Stamford Road, Blacon, Chester, CH1 5DG by 4:00 pm on 11 December 2015 and thereafter is forbidden from returning to the vicinity of the Premises

- **4.** The court found that [following admissions made] she had breached that order by
- i) Being in the vicinity of 15 Stamford Road, Blacon, Chester on 20th July 2016
- ii) Being in the property of 15 Stamford Road, Blacon, Chester on the 21^{st} July 2016
- **5.** and imposed the following sentences for those breaches

breach i) Being in the vicinity of 15 Stamford Road, Blacon, Chester on 20 th July 2016	Sentence i) Two weeks imprisonment suspended for 6 months on the condition that she comply with the injunction
ii) Being in the property of 15 Stamford Road, Blacon, Chester on the 21 st July 2016	ii) Two weeks imprisonment concurrent to i) above.

6. Accordingly it was ordered that the Defendant, Eve Preston, be committed for contempt to prison for a (total) period of two weeks

The order is suspended until 22nd January 2017 and will not be put into force if during that time⁽²⁾ Eve Preston complies with the following terms:

Terms of Original Injunction Order (30th November 2015)--

- 1. Miss Eve Preston must vacate the Premises, 15 Stamford Road, Blacon, Chester, CH1 5DG by 4:00 p.m on 11 December 2015 and thereafter is forbidden from returning to the vicinity of the Premises.
- 2. Miss Eve Preston is forbidden (whether by herself or by instructing or encouraging or permitting any other person) from starting fires in the garden of the Premises or in the vicinity of the Premises.
- 3. Miss Eve Preston is forbidden (whether by herself or by instructing or encouraging or permitting any other person) from damaging the shrubs, trees, shed and grass in the garden of the Premises by fire or any other means.
- 4. Miss Eve Preston is forbidden (whether by herself or by instructing or encouraging or permitting any other person) from engaging in conduct which is likely to cause harassment, alarm or distress to any persons in residence or visiting Stamford Road, Blacon, Chester.
- 5. Miss Eve Preston is forbidden (whether by herself or by instructing or encouraging or permitting any other person) from engaging in conduct capable of causing annoyance or nuisance to any resident or visitor to Stamford Road, Blacon, Chester, or the locality.
- 6. A Power of Arrest is attached to paragraphs 1, 2 and 4 above.
- 7. The Injunction Order above (being paragraphs 1 to 5 inclusive) do remain in force until further order of the Court.
- 8. The Power of Arrest (paragraph 6 above) do remain in force until 4:00 p.m on 30 May 2016.
- 9. Mr David Rogers and Miss Eve Preston do pay Sanctuary Housing Association's costs of the application summarily assessed in the sum of £6,000.00.
