

2. Approaching directly or indirectly Mrs Aileen Holtom, Mrs Maureen Leighton or Mr Gregory Rose.
3. Playing loud music or causing any other noise nuisance to come from the property 118 St Johns Close, Knowle, Solihull B90 0NH.
4. Consuming or allowing others to consume any controlled drugs at 118 St Johns Close, Knowle, Solihull B90 0NH.
5. Shouting, screaming, arguing or use any form of abusive language or allowing any of your visitors to shout, scream, argue or use any form of abusive language.
6. Causing harassment, alarm or distress to any resident of St Johns Close.

The Claimant now applies for an order that you should be committed to Prison. It is alleged that you have disobeyed the Interim Injunction Order in the following ways:

- i. that on Tuesday 6<sup>th</sup> September 2016 at approx. 11:45 pm residents were woken from their sleep to hear you shouting, screaming, swearing and howling like an animal this lasted for approximately 45 minutes, when the police were called,
- ii. that on Wednesday 7<sup>th</sup> September 2016 at approx. 5 am residents were again awoken from their sleep when you were shouting, screaming and howling once more, this lasted 1 hour,
- iii. that on Friday 23<sup>rd</sup> September 2016 at approx. 7:30 am a resident heard you shouting, screaming and howling like a wild animal, the resident could repeatedly hear you shouting about dirty lesbians and dirty old fags, this lasted approximately 1 hour, the resident also heard you opening and closing your door to your flat in a frantic manner, you then left your flat and went in to the rear communal garden and whilst there you were shouting, swearing and howling incessantly, this lasted approximately 15 minutes.
- iv. that on again on Friday 23<sup>rd</sup> September 2016 at 11:45 am you were heard by a resident to be shouting, screaming and howling like a wild animal which

- lasted some time, shortly after an associate left your property you were seen to come out of your property in to the public domain where upon you started shouting, screaming, swearing and howling at the top of your voice whilst walking away from your property,
- v. that at 12:45 pm on Friday 23<sup>rd</sup> September 2016 a resident witnessed you out the front of the block when you were shouting, swearing and gesticulating about dirty lesbians and dirty old fags, you then shouted up to a neighbour,
  - vi. that at 12:50 pm on Friday 23<sup>rd</sup> September 2016 you were again heard to be shouting again that the place was full of dirty lesbians,
  - vii. and that at 1:30 pm on Friday 23<sup>rd</sup> September 2016 you were heard to be shouting screaming and howling like an animal.
  - viii. that on Tuesday 8<sup>th</sup> November 2016 at approximately 6 pm until 6.35 pm you were heard to be shouting, groaning and making sexual noises.
  - ix. that on Tuesday 8<sup>th</sup> November 2016 at approximately 8.30 pm you were heard to be shouting, swearing and yelping. This went on until 9.20 pm when the police arrived.
  - x. that on Tuesday 6<sup>th</sup> December 2016 at approximately 2.45 pm you were heard screaming and shouting. This went on for approximately 30 minutes.
  - xi. that at approximately 5.30 pm on Tuesday 6<sup>th</sup> December 2016 when Mrs Holtom spoke to you, you started throwing your arms around in an intimidating manner that scared Mrs Holtom.
  - xii. that at 11.45 pm on Tuesday 6<sup>th</sup> December 2016 you were heard to be banging the wall and shouting and screaming. This continued for approximately 1 hour.
  - xiii. that at 1.45 am on Wednesday 7<sup>th</sup> December 2016 you were heard to be banging the wall, shouting and screaming.
  - xiv. that at 7:15 am on Wednesday 7<sup>th</sup> December 2016 you were heard to be banging, screaming and shouting. This continued for approximately 10 minutes.
  - xv. that on 6<sup>th</sup> December 2016 you made a threat on Facebook as follows 'Now it's the time to be a saver and kill the neighbour girl you don't like the smell of my deodorant you want to smell my dick after Being in back of your old man'.
