ORDER

Upon the Claimant's Application dated 9 November 2016

AND UPON hearing James Ramsden QC and Samar Abbas Counsel for the Claimant and the Defendants not appearing nor being represented

AND UPON being satisfied that it was just, in all the circumstances, to proceed with determining the Application in the absence of the Third and Fourth Defendants

AND UPON finding that the Third and Fourth Defendants are in contempt of court for intentionally attempting to interfere with the course of justice by (i) knowingly and consciously swearing affidavits which they knew to be false and/or misleading; and (ii) attempting to use these affidavits to remit, suspend, set aside or otherwise interfere with an Order of the Court

IT IS ORDERED THAT:

1. The Third and Fourth Defendants be sentenced for contempt to prison for a period of 3 months, such sentence to be served consecutively with the existing sentence effective pursuant to the Order made by Warren J on 5 September 2016 (the "**Warren Order**").
2. The Warrant of Committal made pursuant to this Order do remain in the Court office at The Royal Courts of Justice and that the Order for Committal be

suspended until 26 April 2018. If, by that date, the Third and Fourth Defendants have satisfied the Court that they have purged their contempt of Court, including the contempt of Court identified in the Warren Order, the Court will consider, in the light of any apology afforded, whether to remit the whole or any part of the sentence imposed on them.

3. The Third and Fourth Defendants have liberty in any event to apply to remit the whole or part of the sentence imposed on them.
4. The Third and Fourth Defendants shall pay the Claimant's costs of this application, such costs having been summarily assessed on the indemnity basis in the sum of £98,962.32 (inclusive of VAT where applicable) within 14 days of this Order, i.e., by 29 March 2018.
5. This Order shall be served by the Claimant on the Defendants, such service to be effective by email.
