- i) On Monday 25<sup>th</sup> March 2019, being with, associating with, communicating with or approaching directly or indirectly including by telephone or any electronic means including all forms of social media and the Internet, the following ... James Harrison (15.07.97) in breach of Prohibition 1 of the Injunction.**
  
- ii) On Monday 25<sup>th</sup> March 2019, being in Kirkstone Road North, Litherland, Liverpool 21, which is an area from which the Defendant is prohibited pursuant to Prohibition 2 of the Injunction made pursuant to section 40 Policing and Crime Act 2009 on 19<sup>th</sup> September 2018;**
  
- iii) Between 13<sup>th</sup> December 2018 and 26<sup>th</sup> March 2019, failing to notify Merseyside Police of his current home address or normal place of residence and update Merseyside Police or any proposed change thereto by giving 5 days clear notice of such change in accordance with requirement 1 of the Injunction.**

5. and imposed the following sentence(s) for those breach(es)
