 - iii) On 5 December 2019 at approximately 08.10 the Defendant was standing in the front garden of the Property using abusive, racist or foul language towards Dominic Sleightholme. The Defendant shouted the words "you black bastard" in a manner so as to cause harassment, alarm or distress to Clare Ford and Dominic Sleightholme.
 - iv) On 16 December 2019 at approximately 21.30 the Defendant was standing in the doorway of the property when she used abusive, racist or foul language towards Dominic Sleightholme. The Defendant

- shouted the words "you black bastard" in a manner so as to cause harassment, alarm or distress to Dominic Sleightholme.
- v) On 19 December 2019 at approximately 23.00 the Defendant was inside the property when using abusive, racist or foul language towards Clare Ford and Dominic Sleightholme. The Defendant shouted the words "I'll get you back you bastards and "you black bastard" in a manner so as to cause harassment, alarm or distress to Clare Ford and Dominic Sleightholme.
