2	<p><b>CORONER'S LEGAL POWERS</b></p> <p>I make this report under paragraph 7(1) of Schedule 5 to The Coroners and Justice Act 2009.</p>
3	<p><b>INVESTIGATION and INQUEST</b></p> <p>The inquest into the death of <b>Linda Gillchrest</b> was opened on 3<sup>rd</sup> September 2020. It was resumed and concluded on 18<sup>th</sup> December 2020.</p> <p>The medical cause of Mrs Gillchrest's death was: <b>██████████ Poisoning</b></p> <p>The inquest concluded with a short form conclusion of: <b>Suicide.</b></p>
4	<p><b>CIRCUMSTANCES OF THE DEATH</b></p> <p>On the 19<sup>th</sup> July 2020 Linda Gillchrest was found by a neighbour in bed at her home address in Guildford, Surrey, there were no signs of life. She had not been seen for two days. The emergency services were called and</p>

	<p>death was recognised at 23:31 hours that same day. A quantity of [REDACTED], which Mrs Gillchrest had bought [REDACTED], was found in the bin situated in the kitchen at her home address. Toxicological tests found high levels of [REDACTED] in her blood, which could not be explained by diet. Further, Mrs Gillchrest had bought an [REDACTED] which gave detailed and clear instructions as to how to self-administer a fatal dose of [REDACTED].</p>
5	<p><b>CORONER'S CONCERNS</b></p> <p>During the course of the inquest, evidence was heard that in May 2019 Mrs Gillchrest bought an [REDACTED] [REDACTED] [REDACTED] of the same name. The [REDACTED] gave very clear and precise instructions as to how to self-administer a fatal dose of [REDACTED], including the amount required and a timeline to death. In that same month, for less than £5:00, pounds, Mrs Gillchrest purchased, on the [REDACTED] a quantity of [REDACTED] [REDACTED] that was in excess of that recommended in [REDACTED] [REDACTED] as being required for a fatal dose. Both purchases were made without any restriction being imposed by the sellers.</p> <p>The <b>MATTERS OF CONCERN</b> are that:</p> <ul style="list-style-type: none"> <li>• A publication such as [REDACTED], that contains detailed instructions as to how to end a human life, is available to be purchased [REDACTED] without restriction.</li> <li>• [REDACTED] is available to be purchased in lethal quantities from a [REDACTED] for less than £5:00, again without restriction.</li> <li>• No protection is afforded to vulnerable people prior to them making such purchases.</li> </ul> <p>Consideration should be given to whether any steps can be taken to address the above concerns.</p>
6	<p><b>ACTION SHOULD BE TAKEN</b></p> <p>In my opinion action should be taken to prevent future deaths and I believe that the people listed in paragraph one above have the power to take such action.</p>
7	<p><b>YOUR RESPONSE</b></p> <p>You are under a duty to respond to this report within 56 days of its date; I may extend that period on request.</p>

	<p>Your response must contain details of action taken or proposed to be taken, setting out the timetable for such action. Otherwise you must explain why no action is proposed.</p>
