Family Justice Council Seminars and Bridget Lindley Memorial Lecture

Adoption in the 21st Century

The Family Justice Council invites you to attend its forthcoming series of seminars and Bridget Lindley Memorial Lecture on adoption in the 21st century.

The primary role of the Family Justice Council is to promote an inter-disciplinary approach to family justice. As an advisory body, it monitors how effectively the family justice system operates. These online seminars will replace the Council's interdisciplinary conference (originally planned for March 2020) and will take place during the week commencing 1 March. The final session will be dedicated to the annual Bridget Lindley Memorial Lecture. Please see the indicative programme below.

The Bridget Lindley Memorial Lecture will take place on Thursday 4 March and will be given by **Baroness Hale**, former President of the Supreme Court. This session will be chaired by **Sir Andrew McFarlane**, President of the Family Division and Chair of the Family Justice Council.

The lecture, now in its fourth year, was set up to commemorate the life and work of Bridget Lindley OBE who died in 2016. Bridget served with distinction as a member of the Family Justice Council and as the Family Rights Group's Principal Legal Adviser and Deputy Chief Executive.

The seminars will be hosted by Mrs Justice Lucy Theis, Mrs Justice Frances Judd and HHJ Jane Probyn. Speakers will include Dr Brian Sloan (University of Cambridge), Judge Anni Højmark (Denmark) John Simmonds (CoramBAAF), Professor Julie Selwyn (University of Oxford), Dr Julie Doughty (Cardiff University), Professor Beth

Neil (University of East Anglia), **Amanda Boorman** (*The Open Nest* charity) and **Lucy Reed** (family barrister, the Transparency Project and *Pink Tape*). The **Family Justice Young People's Board** will also be represented.

The seminars will explore adoption, not only in England and Wales but across Europe and wider, including a presentation from Judge Anni Højmark on non-consensual adoption in Denmark. The seminars will include a look at Special Guardianship Orders, trends in adoption, tracing family members and contact with birth parents. It will also consider the Wales Adoption Cohort Study on early placement success, conducted by Cardiff University, and hear from an adoptive parent and an adopted child about the challenges they faced.
