

# PENDING COUNTRY GUIDANCE CASES and ISSUES

This document gives details of all pending country guidance cases before the Upper Tribunal, Immigration and Asylum Chamber.

It is designed to provide relevant details of intended country guidance cases coming up in the Upper Tribunal, identifying the countries concerned, the relevant country guidance issues (in summary) and what stage the case has reached (e.g. whether it has had a Case Management Review hearing or whether it has been fully heard and the decision reserved). Once a country guidance case has been decided and reported it will be available in the ordinary way on the UKUT IAC case law database and will no longer appear in this document.

Hitherto this resource has been for circulation within the judiciary only. It is now considered that relevant information should be made more widely available.

It is intended that this document is updated regularly on instructions from Upper Tribunal judiciary. However, because for various reasons cases do not always proceed and also because there can be short delays in updating, its contents are NOT to be taken as a definitive statement about such matters.
