I have been a Catholic Priest for 51 years. If I had not learnt how people operate I would not have been able to be a priest in Peckham whose Sunday Congregation went from 300 to 800, who once saved a school I inherited from closure and played key roles in the establishment of centres for the homeless both in London and Kent.

Charlie and his family, have contributed to life at St. Paul's in Dover in many ways. Natalie, the former Mrs Elphicke chaired the committee organising the celebration in Dover Castle of the 50<sup>th</sup> Anniversary of my ordination. A thousand people gathered for Mass in the sun and were fed and watered after too. I know the Elphicke's well.

Charlie Elphicke has been an excellent MP. His ability to think deeply and work for what his constituents actually needed was the reason his majority went up markedly in 2017 when most of his party's figures went the other way. It is this habit of thinking deeply that leads me to hope he will be given a long but suspended sentence.

The man before the court has changed. He is quieter. He sees he has a journey ahead. He is, I believe, far more likely to complete the journey he needs to make if his sentence is suspended. In this case I believe a custodial sentence would do more harm than good. Too much of a shaking is not a good thing.

May I thank all of you who do so much to try and make this world a better place.

To whom it may concern:

My name is Neil Wiggins. I am a 53-year-old company director born in Dover 28/01/1967.

I first met Mr Elphicke, who I shall hereafter refer to as Charlie, in 2010 on the day when he took up the seat in Parliament for Dover and Deal, to which he had just been elected for the first time. I had written to him during the election campaign of 2010 with some ideas as to how the then proposed privatisation of the Port of Dover could be successfully countered in such a way as to ensure that the port would either remain as a Trust Port or be transferred into the ownership of its local community in perpetuity. Charlie's response was to invite my family and I to the Houses of Parliament once he had taken up his position so that I could give him a complete briefing whilst my family were given a tour of The House. On this occasion we spoke for a couple of hours and it was during this meeting that the foundations of what became a successful campaign to prevent the private equity sale of the Port of Dover were laid.

Charlie and I worked closely together on this project over the succeeding 2 years and became friends during this time. We met quite often as families with Charlie, Natalie, my wife, and our children my wife, and our children my wife, and our children my type of significant campaign to alter the course of action chosen by a government, our wives and children joined us on Saturday mornings distributing information, meeting with people and talking to them, helping us to deliver leaflets, attending Town Hall and Village Hall meetings and so on. My experience, and my family's experience, of Charlie during this time was that he was a hardworking, earnest, and honest family man making every effort to serve the best long-term interests of all of his constituents.

With the Government's announcement on December 20<sup>th</sup>, 2012 that the port's privatisation proposals were not approved, the initial campaign was successful. However, it remained important to secure the future of the port and put in place protections for the local community and the port's workers to ensure that the port could not again, in a couple of years, try to repeat the privatisation process. So, Charlie and I continued to work closely together to ensure that overall policies and port governance structures, particularly at Dover, were changed and reformed. After a lot of hard work, these objectives were largely achieved in April 2014 with a major statement from the responsible Minister, Stephen Hammond MP, in Dover. Once again, during this time, my experience of Charlie was that of a hardworking MP determined to achieve the best outcome for Dover and Deal.

Even after the Minister's announcement, Charlie continued to work on this project for a further 2 years to ensure that changes were implemented in a meaningful way. At this point I had to take a step back from campaigning because I was by now a candidate to become one of the port's first

community Non-Executive Directors and it would have been inappropriate for me to continue to work on the project with Charlie.

However, by this time we had become friends and our families were friends and we continued to meet up for BBQs, Christmas and New Year and my family and I lent Charlie and Natalie our assistance during the election campaigns of 2015, 2017 and 2019 (local, EU and General).

The allegations on which Charlie has now been convicted came to all of us as a shock, because at no time since we first met in 2010 had he given me any cause to doubt his propriety or integrity.

I have known Charlie as a man dedicated to working for the improvement of his constituency and of the lives of his constituents. He has been an ebullient character, enthusiastic, almost bouncy, in getting things done in a proper and thorough way.



Of course, I am aware of Charlie's recent court case and his conviction on three counts of sexual assault and the comments that I make today are made in the knowledge of the court's findings.

I have spoken with Charlie since his conviction and he seems very subdued and extremely sad. He has, after all, lost his wife and family, his home, and his job over his behaviour. This is already a great deal to lose and his lack of animation and the buoyant good humour that has always been his 'trademark' during our friendship is quite concerning.

## **Reference for Charlie Elphicke**

#### To whom it may concern

I am aware of the sexual assault charges which Charlie Elphicke has been convicted and the comments here are made with knowledge of the court's findings.

I have known Charlie for about nine years. I first met him socially at a dinner party in Kent, where he was an MP and where we have a house.

In his capacity as an MP, in 2014 Charlie was very quick to respond when there was a lot of flooding in Kent, to the extent that water streamed through our garden and flooded a neighbour's house. Charlie harnessed the support of the local fire service, army and other utilities to help divert the flooding. Pictures of the flooding appeared in the local paper.

In 2019, he was also helpful in supporting the neighbourhood in their objections to attempts to build a new town with 3,750 homes between Sandwich and Deal. The plans were subsequently dropped.

With my wife I have attended two Conservative party events that were organised by Charlie, to enable local people to meet cabinet ministers, and we have met Charlie socially. At all times, his conduct has been entirely appropriate.

My impression of Charlie is of a hardworking, family orientated, upstanding member of the community. We have known about the allegations against him since the whip was withdrawn in 2017 and, despite the enormous pressures he and his family must have been under, he continued to be hardworking and focused on supporting his constituents. This positive attitude included supporting his wife Natalie when she ran to replace him as the MP for Dover.

With the loss of his job and break up of his marriage we are all very worried about Charlie, who must be under intolerable pressure.

The following comments are made in the complete knowledge of the recent charges, trial and conviction of Charlie Elphicke for 3 counts of sexual assault.

When Charlie Elphicke was the MP for Dover and Deal he was of great help to me personally and the district as a whole.

I met Mr Elphicke in 2014 at a job fair in Dover; this was really well attended and a welcome event. We also met at a Street Pastor commissioning where I offered my services to his campaign for re-election. He was very easy to talk to and listened to me, I found his personality cheery and enthusiastic about Dover and what he hoped to achieve for the town in the future. His personality has always been positive and cheery really.

Mr Elphicke worked very long and hard to have that hospital built; it really is a great asset for Dover. For me personally, my entire physio programme was done there too, saving a long drive to Margate. I know a lot of people are very grateful indeed to him for the work he did to achieve our new hospital, where we can go for blood tests and x-rays and other procedures saving a long trip to Ashford or Margate.

I volunteer in a shop

book shop, Mr Elphicke visited the shop twice when he was an MP, the second time to celebrate the shop reopening after a terrible flood due to a leaking water pipe, no press were there, he took time out of his busy schedule to do this. He had helped greatly when the water company had sent the proprietors a huge bill. I was so grateful to him for helping so I could go back to my volunteering there and the shop could fully open again.

My husband works at the Eastern Docks Dover and is also grateful that the docks were not sold off, a process which Mr Elphicke stopped successfully after a long hard campaign.

His help with the Western Docks extension is well documented and has meant more work for people of Dover.

Speaking to Mr Elphicke during the trial and after the conviction, I find him quite withdrawn now.

I am delighted to pen this testimonial to CHARLIE ELPHICKE whom I know only as a constituent of his former Dover parliamentary seat.

It should also be noted that I am not a friend of his, nor a member of, or supporter of the Conservative Party.

One further point I am well aware of the court proceedings against Charlie and the subsequent findings.

That said I very much wish to state that I had occasion to need Charlie's support during a very stressful encounter with Affinity Water who suddenly decided to end decades of custom and practice and refuse to maintain our water supply ... a feeder system from the main supply about two miles away. Apart from the emotional entanglement we stood to lose thousands in go-it-alone costs of maintaining the system ourselves. I wrote to Charlie in desperation asking for his intervention. To be honest I expected nothing. But he responded quickly, wrote to Affinity, and the whole matter was settled in our favour in 48 hours.

He wrote to me outlining his actions. It was a very kind letter expressing the hope that we would be happy at the end of the matter. He did not have to be so kind. He could merely have emailed rather robustly and left it at that. The manner of his response overwhelmed me. So much support, so much empathy, so much genuine interest in our fate.

I repeat, I never sing the praises of politicians, but this man is an absolute diamond of a human being and we are forever in his debt.

I first met Charlie Elphicke in July 2010, shortly after his election as Member of Parliament for my constituency. I had approached the British Council for help with promoting some of my novels. The British Council had refused in a manner that I thought unreasonable. I took my complaint to Mr Elphicke. After he had written a letter, the British Council changed its mind and cooperated in a book tour of the country.

My most recent approach to Mr Elphicke for help was in November 2018. My daughter's music school had recently moved to larger premises. Its director had learned from an informal approach that these premises would not be liable for business rates. After moving in, the school was sent a rates demand for £15,000. I wrote to Mr Elphicke on behalf of the school to ask for help. His response was immediate and effective. The rates demand was withdrawn. I enclose a copy of Mr Elphicke's reply to my request for help.

On the basis of this personal matter and this matter of wider community interest, and on the basis of other matters that it would be redundant to list, I will say that I found Mr Elphicke to be an outstanding constituency Member of Parliament. In the near-decade that he sat for my constituency, he was always approachable, always sympathetic, always prepared to help in matters where he could legitimately intervene.

I regularly met him in the streets of Deal. I was invited twice into his house in St Margaret's Bay. On all occasions, I found him affable and even charming – never distant or overly aware of his status as a Member of Parliament.

I am aware of the charges of sexual assault of which he was convicted earlier this month. I am writing in full knowledge of the evidence given against him by the prosecution, and I write this letter in the hope that it may be useful in any subsequent hearings.

With regard to the accusations and the Court verdict, while I accept the verdict, and am aware of his tearful confessions of adultery, I am deeply shocked. - I am a retired officer of HM Customs & Excise in the United Kingdom, and after retirement I was subsequently engaged by various countries and organisations as an international management consultant. I have attached to this Paper my Curriculum Vitae (Annex 1) to establish and confirm my declared status. I am fully retired now.
- 3. I am aware of the three charges of sexual assault which Mr Elphicke has been convicted of and that the comments made in this paper are made in the knowledge of the court's findings.
- 4. In 2008 my wife (Mrs Carmilla isobel Alexandra Fitt of the same address as myself) and I returned to the United Kingdom after about twenty years working and living overseas (see attached CV). We decided to return to the Dover area to live because we had lived there before. Unfortunately we arrived just as the UK entered into a major recession. Within weeks of our arrival our British bank (Kaupthing Singer & Friedlander (Isle of Man)) went into liquidation. This resulted in us being unable to access our money.
- 5. The bank was based in the Isle of Man and help and assistance was not available from either the British or Isle of Man Governments - or any other authority for that matter. Even though I had no fixed address in the Dover area (I was staying with a friend in a village near Dover) I contacted the Dover and Deal Member of Parliament at that time Mr Gwynfor Matthews Prosser. He was unable to give me any assistance or advice. I contacted many other politicians and financial experts also at that time with the same negative results.
- 6. In some desperation I then contacted the prospective candidate Conservative MP for Dover and Deal constituency in the approaching general election who was Mr Elphicke. This was my first contact with Mr Elphicke and it was by email.
- 7. His response was very positive and helpful. Within the constraints of the situation that I was in he gave me constructive advice and laid out the various scenarios and options that could arise. He also kindly arranged for me to meet Sir Roger James Gale MP for North Thanet in Kent. This I did on 21<sup>st</sup> May 2009. Mr Gale specialises on the interests of British expatriates and raises issues concerning them in the House of Commons and directly with Government. Mr Gale listened carefully to my story gave me good solid advice and stated he would follow up the case as best he could. This he did admirably.
- 8. Mr Elphicke, in the meantime, kept in contact with me giving support and advice when necessary. Then in May 2010 he was elected MP for the constituency of Dover and Deal in Kent. This was the constituency in which my wife and I came to reside permanently. The liquidation of my bank progressed predictably and I managed to put my finances in some sort of order.
- 9. Even though I am not a Conservative party member I maintained contact with Mr Elphicke, mainly by email and letter. I only met him briefly on a few occasions, normally at various functions but occasionally we would meet by chance in the street or harbour promenade when I was walking my dog. I had no other personal contact with him and had no knowledge of any of his private life other than that I read online and in the newspapers.
- 10. Once Mr Elphicke became the MP for Dover and Deal in 2010 he became very proactive with local issues, especially the Port of Dover. I was, and am still, very interested in matters arising and concerning this Port. This is because I worked in the port as Customs Officer for over ten years from 1970 onwards. From 2010 onwards there were many issues that concerned the Port of Dover, Border Force and HMRC. The latter two organisations being the successors to HM Customs & Excise who used to employ me.

- 11. Mr Elphicke and I appeared to share similar interests and concerns in these areas, although we did not always agree. However our contacts were always amicable. Some of the issues that he was proactively involved in over all the period he was MP included:
  - a. Poor Border Force smuggling controls and activities.
  - b. All immigration issues especially 'migrants'. This has been, and still is, an ongoing problem ranging from the migrant camp in Calais (which he visited) to people smuggling by both vehicle small boats. He gave, and was seen to give, strong support, as well as challenges, to the authorities dealing with this issue (mainly Border Force) both in Dover, in the House of Commons as well as directly to the appropriate Government departments.
  - c. The ruinous split (in my opinion) of anti smuggling activities between HM Revenue & Customs and Border Force.
  - d. Issues arising from the dredging of the Goodwin Sands to infill part of Dover Docks. (Amongst other activities he attended and supported the presentation of a petition against this activity by protesters at Number 10 Downing Street).
  - e. Support of Dover Harbour Board with the regeneration of Dover Port.
  - f. Fact finding and liaison contacts with Port employees of all organisations working there and various French authorities in Calais. This improved the general knowledge of all on various issues that existed and enhanced communications generally.
  - g. Brexit. When the referendum arose I was, as were many others, very confused and did not know the best way to vote. Mr Elphicke was a 'remainer' (in a predominantly 'Brexit' constituency) but gave clear views to the public as to the pros and cons of both. He also gave clear objective advice to any constituents who asked him directly. That included me. He also made Brexit related visits to all of the Port organisations to see for himself the preparations needed for Brexit. This information he used to good effect in supporting Dover Harbour Board, ferry companies and others with their concerns, taking these concerns up with the Government, in the House of Commons and elsewhere.
  - h. Noise. When I lived on the seafront of Dover Harbour in a Dover Harbour Board owned apartment (just before we moved to our present address) we were beset by a cacophony of noise from the dredging in the harbour through to major repairs being done to our building. The noise was acceptable during the day time but not at night. Mr Elphicke supported our appeal to DHB and monitored the noise levels and timings.
- 12. It can be seen from Para. 11 above that the issues I was concerned and interested in were mainly connected to the sea and harbour, but he was also very active in the many other areas of constituency matters arising. But Paragraph 11 above shows that he objectively trod a delicate path between his constituents concerns and those of the appropriate authorities. It was skilfully done.
- 13. As I stated in Para. 9 above our contacts were mainly by email and letter. Unfortunately I destroyed all his letters to me when we moved to our present home here in Surrey. However I have copied below a brief exchange of emails that we had in 2016 in the post Brexit referendum period. The content is unimportant but I have copied it to show an example of the tone in which our exchanges took place. This being a type of relaxed formality that only covered the issues and concerns I raised and nothing personal from either of us was discussed. I found his character and personality helpful, caring, industrious, motivated, and friendly but not over familiar.
- 14. My wife and I were part of the congregation of St Mary in Castro Church within Dover Castle. We also had social dialogue with other sections of the Dover / Deal community. The point being that from the moment Mr Elphicke became the Member of Parliament for Dover all his constituents with whom I had contact with were very satisfied with his support and representation of the community. He regularly visited all parts of his constituency including occasional attendance at our church, where he was always warmly welcomed.
- 15. During the pre-trial period we maintained the normal spasmodic email contact we always had. I saw no change in his tone or behaviour. It seemed to be 'business as usual'. In fact I saw him on television a few

times in the 'House' participating normally with parliamentary questions and debate. Of course my lack of intimate contact with Mr Elphicke resulted in me having no knowledge of his personal feelings or demeanour.

- 16. As you can see from above it is my opinion that Mr Elphicke was an excellent, highly respected, hard working and effective Member of Parliament for Dover and Deal who communicated very well with his constituents and with all others with whom he made contact. He is a great loss to that community by no longer being their MP. Also lost to the Government, and our country, is his hard earned expertise on Dover Port, Brexit, border controls, etc. However Mrs N Elphicke MP is a very worthy successor.
- 17. Finally, even though my wife and I have moved away from Dover I still have an interest in Dover issues, its Port, Brexit, Border Force, etc hence my continued contact with Mr Elphicke and now his wife Mrs Natalie Elphicke as past and present MPs for Dover and Deal.

This has involved door-to-door campaigning, street stalls, fund raising and literature distribution. I have entertained and been entertained by Charlie and his wife throughout this time.

We are fully aware of the charges of which Charlie has been found guilty by the Courts and our remarks are made regardless of their findings. We have come to regard Charlie as a friend who had genuine concern for us in our time of need. He was, we believe, a model Member of Parliament and regard his downfall as a tragic loss to ourselves, to his former constituents and indeed to the country which he so ably represented. We sincerely hope that he will be permitted to find an appropriate way of reapplying his undoubted talents to public service as soon as possible.

I am the Chief Executive of Dover District Chamber of Commerce. I am a Director or Chairman of nine other active UK companies. I am a trustee of two charities and a governor of Broadstairs College. I chair East Kent Business Advice Clinic and sit on the boards of the Care Leaver Progression Partnership, Manston Skills & Employment Board and Southern Water Stakeholder Kent Panel. I am a member of two hospital trusts and Chairman of Mersham-Le-Hatch Cricket Club. Since 2005, I have been a Fellow of the Royal Society of Arts, Manufactures & Commerce.

I first met Charlie Elphicke on 25<sup>th</sup> September 2007, when he was the guest speaker at a business breakfast organised by the Chamber. At the time, he had just been adopted as a prospective parliamentary candidate for Dover. He introduced himself to the delegates with self-deprecating good humour as another simple lawyer in the honourable tradition of previous members of the legal profession who had represented the constituency and claimed that he had been incorrectly labelled by the News of the World as "a leading economist".

Before his success in the General Election of 6 May 2010, I met him on one further occasion in his office at 30 St Mary Axe when we discussed the measures required to boost the economy of Dover.

Along with my fellow Directors at the Dover District Chamber of Commerce, we monitored his public statements and activities in the Dover constituency with much care and attention during the first eight months of his first period as a Member of Parliament. Impressed by his attention to detail on business issues and prompt responses to questions to his constituency office, I wrote to him in January 2011 with an invitation to accept the post of Chamber of Commerce President which he duly did.

As might be expected, we corresponded regularly on commercial issues related to his constituency.

In his first five years in office, one of the key threats to the future prosperity of Dover and its environs was the attempt by various individuals to engineer the sale of the Port of Dover to an overseas consortium which did not appear to have the best interests of Dover residents and workers at heart.

Charlie Elphicke was the driving force behind the formation of Dover People's Port Trust Limited (DPPT), a Registered Society formally established in August 2010 under the Industrial & Provident Societies Act 1965 with the declared aim of redirecting the port along a path that benefited locals and the UK in general.

Charlie Elphicke's boundless energy and unflagging enthusiasm inspired others to accept the essential virtue of the campaign. With the backing of Sir Patrick Sheehy, Dame Vera Lynn and prominent figures from across the political spectrum, Charlie Elphicke organised a town referendum in March 2011 which supported the case for the port to remain under British ownership by 5,244 votes to 113. The plan to sell the Port of Dover to foreign interests was subsequently dropped and Charlie Elphicke was rightly applauded for his community spirit and patriotic fervour.

Charlie Elphicke also helped to secure the £24 million required to build the new Buckland Hospital in Dover which reopened in 2014. Given the recent pressures on the NHS caused by the COVID-19 crisis, the residents of Dover have every reason to be grateful for Charlie Elphicke's foresight and successful fund-raising.

At many DPPT board meetings, company visits and evening events, Charlie Elphicke proved to be a genial companion with a ready wit. When reading of his conviction on 30<sup>th</sup> July 2020 on three counts of sexual assault, I reviewed the many occasions when I had been with him in mixed company. I cannot recall any time in the past thirteen years when his behaviour fell below acceptable standards. I never witnessed him being disrespectful by word or deed to those around him.

Charlie Elphicke was widely expected to achieve ministerial office with a senior cabinet post a likely consequence of his success in the constituency and confident oratory in the House of Commons. He was prepared to undertake the hard work necessary to complement his ambition, keen perhaps to be one of the exceptions to Enoch Powell's declaration that "All political lives, unless they are cut off in midstream at a happy juncture, end in failure". It is a matter of regret by those who admired and respected his support for his constituents and local businesses that a most unhappy juncture cut short his promising career in mainstream politics.

I have spoken to him once on the telephone since his conviction and it was immediately apparent that the cheerful bonhomie that defined his public persona was notably absent. I trust that appropriate professional counselling services will be made available to him. I also trust that the significant contribution by Charlie Elphicke towards an improvement in the daily lives of Dover citizens and the public facilities available to them will be given every consideration when he is sentenced.

I am writing in reference to Mr Charles Brett Anthony Elphicke, who is appearing before the court due to 3 x counts of sexual assault.

I feel strongly about Charlie and about his future. Therefore, I am writing this character reference based on the person I know and respect. My view of him is not diminished despite the charges he now faces.

I met Charlie approximately 10 or 11 years ago when I volunteered to assist the local Conservative Association in their bid for him to become the MP for Dover and Deal. Over a period of time I have found him to be honest, hardworking, sincere, caring and fun. My husband, was facing immigration problems. Charlie was aware of this and said should he be elected he would, without making promises, ask that my husband's case be looked into. I thought no more of it. However, within 6-8 weeks of Charlie's Election win we received a letter from the then Home Secretary to say my husband would be considered for British citizenship. This had been a 16 year battle for us. Without Charlie's assistance this would never have happened. We were beyond relieved and ecstatic. Charlie restored our faith in human nature. We recognise him for what he is which is at heart a good man, who could have turned the other way, forgotten about us or was just in politics for himself. We believe he is a rare human being and we still hold him in high esteem and regard him now as our friend. Additionally, a couple of years ago, I had some problems with HMRC. I tried to sort it myself, but was getting nowhere. I contacted Charlie and he intervened, and the matter was resolved (at the time there were a lot of stories in the UK press re HMRC problems so I wasn't the only one). Charlie was a phenomenal MP for Dover and Deal and the local community benefitted massively because of his hard work.

I know from being on the campaign trail with Charlie and the team his positivity, sincerity, confidence and leadership was infectious and real. Everyone wanted to be with and on Charlie's side, and bask in the glow. I saw this effect on numerous occasions with my own eyes over many years. My husband and I attended many Election nights, Association evenings or events. We never saw Charlie behave or speak in an inappropriate/unprofessional way with anyone at any time. I, personally, have never heard anything negative about Charlie from anybody.

Prior to moving to Spain nearly 4 years ago, I worked full time as an Independent Living Manager for a major Registered Social Landlord in Kent and for 2 years sat on Dover Town Council From time to time, in the latter capacity, I would also see Charlie at Public Meetings and various functions and, again, his behaviour was always professional. Although I haven't seen Charlie in person recently when I did speak to him briefly on the phone a few days ago I could tell things are bleak and dark just by his tone of voice. The very least I can do, and my husband concurs, is to support him now for the person we know and trust.

First met Charlie at the Hustings at Dover Baptist Church prior to the 2010 election.

Following Charlie's election to Member of Parliament for Dover we held a small reception to congratulate him, where we presented him with a Bible. The press was present on this occasion and a report went in the local paper.

Charlie served Dover well during his time as their MP and in general he was regarded as a very hardworking kind considerate man who achieved many good results for the town all of which will be on record.

On a more personal level: we have had reason to contact him and found him to be very willing to help, write letters and follow up on the results. I.e. When our friend who suffers from Schizophrenia was sectioned on two occasions, we had cause to react to how she was treated, and Charlie was extremely helpful.

Also, when we were found to have a massive (undetectable) water leak under the shop floor. We received water bills amounting to eight thousand pounds, Charlie once again wrote letters, and during this time asked if he could make an appointment to come to the shop to chat about it to us and our staff. We once again made a little tea party of it. There was no press present he just wanted to ask how things were going.

Charlie has appeared very controlled during the – almost three years – taken for the investigation but it is obvious that the waiting has taken a toll.

The above comments are made with full knowledge that Charlie Elphicke has been convicted of three counts of sexual assault.

Charlie was our MP for at least nine years and a good one too. He has done many good deeds for the people of Dover and Deal. First time we met Charlie was at Dover Port when he and Vera Lynn fought to stop the sell off of the Port of Dover to France in 2010.

He has a very positive attitude towards helping and developing Dover and Deal. We were impressed with him then because he showed genuine care and compassion for the community.

We have a son who has significant additional needs and he lived in private supported living supplied by his care manager, but our son was not happy with the care he was receiving, thus was very unsettled. We didn't know where to turn and what to do to help our son as the care manager had not been very forthcoming despite the amount of times we complained to him. As our last resort, we contacted our local MP, Charlie Elphicke.

We are ever so grateful for Charlie's help and kindness over this difficult period.

Again, last year, we also wrote to Charlie to assist

She waited for an appointment for almost a year but after writing to Charlie, this problem had been resolved. Charlie and his team once again proved how efficient and helpful they were.

To show our gratitude to Charlie, we volunteered to help out during the 2019 election campaign. During this time, Charlie showed professionalism, enthusiasm, dedication and passion for the cause. In spite of the current conviction, we can only speak as we find, he was also very supportive to his family during the campaign and came across to us as a very respectable family man. We also found that, during the campaign there were so many who were grateful for his understanding of the problems the people faced and the assistance Charlie had given them over the years.

We can confirm that we are aware of the charges of which he has been convicted (x 3 counts of sexual assault) and that the comments made in the reference we made are in the knowledge of the court's findings.

My name is Jonathan William Patrick Aitken of My date of birth is

I am a Prison Chaplain serving at HMP Pentonville and also an ordained Priest serving as Assistant Minister at St Matthew's Church, Westminster.

Most of my previous career was spent in politics as a Member of Parliament and as a Minister of the Crown.

I am the author of several books and in recent years I have done extensive charity work particularly in the field of Criminal Justice and Offender Rehabilitation.

I have known Charles Elphicke for over 20 years. I first met him in 1998 when he came to see me in my home near Deal to ask my advice about the prospects of becoming a Conservative Parliamentary Candidate for one of the East Kent constituencies. I had just retired (compulsorily!) from front line politics after serving 24 years as Member of Parliament for East Kent constituency of South Thanet which is next door to the Dover and Deal constituency.

In due course Charles Elphicke was selected as the Parliamentary Candidate and then elected as the Member of Parliament for Dover and Deal. I saw him occasionally and I heard about him frequently because I continued to live near Deal, the second largest town in his constituency, where I have many friends and acquaintances.

Charles Elphicke earned a good local reputation as a hard working Constituency MP. The adjectives I often heard spoken about him by his electorate were "kind", "hardworking", "energetic" and "effective".

When Deal Hospital was threatened with closure he fought and won a battle that has ensured it has stayed open. He also campaigned successfully for the building of the new hospital in Dover.

Charles Elphicke's greatest achievements in terms of local and regional impact was to oppose the privatisation of the Port of Dover. Instead Charles Elphicke successfully argued for the Port to remain in public ownership and to become a community led port. It resulted in the creation of what is called "The People's Port" of Dover, a community led port, which successfully runs and manages the huge Channel Port to this day. Charles Elphicke's achievements in creating "The People's Port" won much acclaim across all political boundaries.

The adjective "kind" was often applied to Charles Elphicke in his constituency because of his caring attitude to the casework that he handled at his local "surgeries" as the MP for Dover and Deal.

In the last few weeks, since his conviction, I have seen and talked to Charles Elphicke for personal and pastoral reasons. As a former prisoner and now a Prison Chaplain myself I have been able to offer him some advice and guidance on how to handle the life of a prisoner if he should be given a custodial sentence.

I have also had spiritual conversations with him. He is a committed Christian and regular churchgoer. He has made it clear to me, that he is deeply remorseful for his failings of character and behaviour which have led to his conviction. I am certain that his penitence is sincere.

I hope and pray the Court will temper justice with mercy when handing down its sentence on Charles Elphicke.

#### To Whom it may concern



I have never met Mr Charlie Elphicke in person, nor am I a member of the Conservative party. I have spoken to him just the one time on the telephone. I have not followed the case, but I am aware of the fact that he has been convicted of sexual assault. I have no information about his private life as I do not know any of his family. My reason for writing is to provide you with my own experience of Mr Charlie Elphicke, his work for the people of Dover, the wider area; and for him helping my business over serious issues with a credit/debit card gateway provider.

It is well known that Mr Elphicke has worked tirelessly for the people of Dover and the surrounding towns. He got involved in all manner of projects from small community and school fetes to stopping the sale of the Port of Dover, campaigned for improved train services, particularly for Deal and in doing so helping to gain access to the high-speed line for constituents. He battled and saved Buckland Hospital in Dover, and we now have a new £24million hospital on the site of the old one. Dover now has an impressive new shopping facility in the heart of the town creating jobs and drawing customers from surrounding towns.

I own and operate a small online business. In early 2019 we experienced a number of orders for products that turned out to be the work of online criminals using stolen Credit/Debit cards. I won't give the name of the Gateway Provider, but they were not at all sympathetic to our financial loss.

A quick look online revealed that we were not alone, as many small businesses had suffered financial loss as a result of online fraud and this provider had treated them all in the same unsympathetic manner in which they treated us. I was (at that time) a member of the Federation of Small Businesses and I approached them for some help. They did not want to help. I won't go into detail as to why, but it would raise a few eyebrows if I did.

I found myself getting nowhere so I decided to email Charlie Elphicke and ask for his help. Within a fairly short period of time he wrote to me and asked for me to provide an overview of what had happened. At this point in time Brexit was constantly on all news channels and I was told that his office was inundated with calls and emails from those for and against it.

As the year moved on and with talk of a General Election looming I expected him not to be able to help me due to the sheer volume of work and commitments he already had. What surprised me is that he wrote to both the gateway provider and the Federation of Small businesses, and he wrote subsequent letters when I was able to provide him with further information. It was only after he stood down as an MP did his work for us come to an end.

I am not here to comment or make judgement on Mr Elphicke'. I could have distanced myself from what has happened, but I felt it should be noted that on a personal level and from my observations of the wider community Mr Charlie Elphicke contributed so much, and his commitment and tireless efforts have made Dover and the surrounding area a better and more prosperous place to live.

I write in support of Mr Charlie Elphicke. I have known him for about ten yearsbefore he became a Member of Parliament when he was a partner in a firm of solicitors.

I got to know him very well after he became the Member for Dover where I live. We worked closely together in particular in establishing the Dover Peoples Fort Trust (DPPT) which we were moved to do when the Dover Harbour Board announced their intention of listing the Board's shares on the Stock Exchange, thereby rendering the Port vulnerable to foreign ownership.
