ORDER

PENAL NOTICE

ANY PERSON WHO DISOBEYS THIS ORDER OR DOES ANYTHING WHICH HELPS OR PERMITS ANY PERSON TO BREACH THE TERMS OF THIS ORDER MAY BE HELD TO BE IN CONTEMPT OF COURT AND MAY BE IMPRISONED, FINED OR HAVE THEIR ASSETS SEIZED.

UPON APPLICATION by the Claimant by Part 8 Claim Form dated 13 June 2018

AND UPON the Claimant having pleaded guilty at Manchester Crown Court on 23 July 2015 to offences under section 59 of the Terrorism Act 2000 and having been sentenced to detention for life with a minimum term of 5 years on 2 October 2015 ("the Criminal Proceedings")

AND UPON HEARING Counsel for the Claimant, Counsel for the First Defendant and Counsel instructed as *Amicus Curiae* at a hearing on 28 February 2019

AND UPON CONSIDERING the written submissions of the Press Association at the said hearing

IT IS ORDERED as follows

INJUNCTION

1. No matter relating to RXG can, during his lifetime, be included in any publication if it might lead members of the public to identify him as (1) the defendant in the Criminal Proceedings; and/or (2) the claimant in these proceedings.

VARIATION OR DISCHARGE OF THIS ORDER

2. Permission is granted to apply by Application Notice to discharge or vary Paragraph 1 of this Order upon giving not less than 72 hours' notice to the parties.

PROTECTION OF HEARING PAPERS

3. Any non-party who makes an application to vary or discharge this order and to whom documents are disclosed by the parties (whether pursuant to CPR Part 25 PD25A §9.2 or otherwise) can use those documents and the information contained in those documents only for the purpose of making the application.

INTERPRETATION OF THIS ORDER

4. An individual who is ordered not to do something must not do it himself or in any other way. He must not do it through others acting on his behalf or on his instructions or with his encouragement.
5. A company or any other entity that is ordered not to do something must not do it itself or by its directors, officers, partners, employees or agents or in any other way.
6. "Publication" in Paragraph 1 includes any method of dissemination of information, including but not limited to, any newspaper report or other written publication, television or other visual transmission, radio or other audio transmission, any posting on the internet and/or any posting on any form of social media/networking platform.

COSTS

7. No order for costs, save that the Claimant's publicly funded costs be the subject of detailed assessment.
