Introduction

Although employment tribunals are used to dealing with parties who are unrepresented and our procedure is relatively informal, many cases are more complex than they may at first seem. It is a fact of life that the more involved in a case you are the easier it is to overlook its weaknesses and to overestimate its strengths.

Advice and guidance from an experienced out-sider before the case is heard can be just as valuable as representation at the hearing itself.

This is a list of some organisations where you may be able to get free advice and/or representation. The organisations give different types of help. Some offer legal advice. Some may represent you at the hearing. Some only offer emotional support. The websites usually explain what kind of help can be given.
