1. Introduction

MF welcomed participants to the User Group Meeting [UGM] for ACL alone, indicating that on this occasion it was being held separately from the Administrative Court in Manchester [ACM].

2. Matters Arising

The minutes from the last UGM (jointly with ACM) had been published. There were no matters arising as such, however MF confirmed that Deputy High Court Judge Karen Ridge was, as envisaged, now available to assist with ACL planning cases in addition to ACM ones.

3. Approach to non-disclosure orders for court documents, specifically in relation to regulatory interim order extension proceedings.

KP raised this as a general topic to gauge what approach was taken in other interim extension regulatory proceedings. Social Work England cases are handled at ACL. Regulatory interim proceedings may themselves be conducted privately but once they reach the High Court for an extension to the interim order, they are dealt with at a public hearing and not routinely anonymised. The Court has the usual powers including to restrict access in an appropriate case to documents from court records in accordance with the Civil Procedure Rules. MF referred to a recent GMC case* at ACM which had raised the question of an Order restricting access to documents. MF said he had understood that the GMC's concerns had resolved because express CPR protections in CPR 5.4C ** were considered sufficient. MF said that, if any issue arose it would need to be determined in the case on which it arose, it being for regulators to consider any issue about communicating with respondents to these applications.

4. Timescale for sending of sealed orders.

HF raised the question about how soon approved orders could be expected (with reference to SWE cases) where existing interim orders were due to expire. NC confirmed that these are prioritised and should be received within a week, but if not, it was appropriate for a chaser email to be sent by way of a 'nudge'.

5. Any other Business.

There were no other matters.

6. Date of next UGM.

MF confirmed that the date would be fixed and circulated by email. The expectation was for 3 short Meetings per year, conducted remotely. He encouraged all interested persons to communicate with ACL.
