| 4 | CIRCUMSTANCES OF THE DEATH <br> Before he jumped off the roof, $\square$ called the Metropolitan Police Service (MPS), who in turn called the London Fire Brigade (LFB). |


|  | When police officers tried to negotiate with him, <br> receptive to the idea of coming down off the roof safely. Police officers <br> were reluctant to suggest that he return the way he had come, as by now <br> it was raining and they were concerned that he would slip, and so he <br> waited on the roof for firefighters to escort him. |

| 5 | CORONER'S CONCERNS <br> During the course of the inquest, the evidence revealed matters giving <br> rise to concern. In my opinion, there is a risk that future deaths will occur <br> unless action is taken. In the circumstances, it is my statutory duty to <br> report to you. |
| The MATTERS OF CONCERN are as follows. <br> 1. <br> actually jumped off the roof. Police attended immediately and <br> sought firefighter assistance immediately. However, they <br> reported to me at inquest that there was some delay in the <br> attendance of LFB. <br> 2. Upon attendance, firefighters recognised that their ladders would <br> not reach the roof of the flats and so called for an extended height <br> ladder appliance. This had to travel from further afield and <br> became more agitated during the wait. It had not arrived |  |
| at 5.33pm when he jumped. |  |
| The police were especially concerned that the extended height |  |
| Tadder appliance had not been requested from the outset, given |  |
| lhat the call was in respect of a person on the roof of a block of |  |
