## Introduction

Mr Justice Fordham welcomed all those joining the meeting and explained that a list of the team members for the ACM is included in the agenda (pasted below).

### Matters arising from minutes of meeting 22.05.2023

Mr Justice Fordham asked Jessica Turner to make a note to follow up on the issue highlighted in the minutes of the previous meeting concerning old versions of rules being used in listing notices. He also referred to Natasha Gaffey's minuted comments that there were some difficulties being experienced at ACM and that court users could contact her if there were difficulties to be resolved. Mr Justice Fordham highlighted that it had been a difficult year for the court, and that feedback is always welcomed whether that is positive or negative. ACM has a new team and a new Lawyer and is looking forward.

### Discussion topics

Questions from GLD:

- Questions had been received from a colleague of Louiza Antoniades at GLD (Sophia Khan). Natasha Gaffey had replied to these questions by email.
- Mr Justice Fordham explained that the first question was in relation to use of an email address for the court that had resulted in a bounce back. Natasha confirmed the email address for ACM is the one on the justice.gov website and "justice" had been missed from the email address in communicating with ACM in that instance.

- Mr Justice Fordham explained that the second question asked about making contact with the court if there are difficulties in a particular case. This question had been raised in the context of a planning matter where notification of a hearing came at short notice and another where paper permission had been delayed. Natasha Gaffey explained that although there are still some issues with migration and CE File, the ACM team has drastically shortened the response lead times. Question from Mathieu Culverhouse (Irwin Mitchell):

- Mathieu Culverhouse asked whether it is possible to give current timescales for paper permission applications.
- Mr Justice Fordham said he was happy to communicate, to and through the User Group, that his own target as Liaison Judge is 3 months for paper permission applications, and quicker in planning cases or cases with urgency. He noted that there can be several reasons that make this challenging.
- Natasha Gaffey added that this is the team's target but with migration difficulties and the backlogs cases have slipped through this net. Natasha re-emphasised that if there is a significant delay, court users can get in touch with her.

Other input from ACM:

- HHJ Bird explained that the ACM Team is working hard on the backlog and highlighted the importance of the channel for communication with Natasha Gaffey.
- Mr Justice Fordham highlighted, as an example of the avenue of direct communication, that GMC had recently raised some practical issues and that this had led to Natasha Gaffey addressing these issues. He was aware of these communications but Natasha Gaffey had handled the issues. David Dolan also thanked Natasha and the team for resolving these issues and explained that there had been a significant improvement through communicating with Natasha and that has been sustained.
- Katie Agada introduced herself as the new lawyer at ACM, having taken over from Laura McMullan.

# <u>AOB</u>

- Mr Justice Fordham asked that all courts users should (a) be conscientious and suitably restrained in relation to emailing ACM (b) ensure that the email "subject" line identifies the case and has a few words about what is being sought and when (c) keep the contents of emails brief and clear. This is all very helpful, when triaging and prioritising work, and for dealing with our cases efficiently and without unnecessary distraction.
- Mr Justice Fordham closed the meeting by expressing his gratitude to the team at ACM and his clerk (Jessica Turner) for their hard work this year and by reminding users to keep in touch with the court about any concerns or feedback.

<u>Date of next meeting</u>: The next ACM:UGM will take place in the Spring with the date to be confirmed.
