Mr Justice Zacaroli took Silk in 2006 and was appointed as a High Court Judge to the Chancery Division in 2017. He was President of the Upper Tribunal, Tax and Chancery chamber between 2018 to 2021. He has been Supervising Judge for the Business and Property Courts, Midlands, West and Wales Circuits, since 2021 and Chair of the Insolvency Rules Committee, since 2018. He was appointed a Lord Justice of Appeal in June 2024.
