3. Pursuant to CPR Rules 5.4C and 5.4D:

(i) A person who is not a party to the proceedings may not obtain a copy of a statement of case, judgment or Order from the Court records unless the statement of case, judgment or Order has been anonymised in accordance with paragraphs 1 and 2 above.

(ii) If a person who is not a party to the proceedings applies (pursuant to CPR r.5.4C(1B) or (2)) for such permission to inspect or obtain a copy of any other document or communication, such application shall be on notice to the First and Second Defendant's solicitor.

4. The Court file shall be clearly marked with the words "An anonymity Order was made in this case on 14 August 2025 and any application by a non-party to inspect or obtain a copy document from this file must be dealt with the terms of that Order"

5. Any interested party, whether or not a party to the proceedings, may apply to the Court to vary or discharge this Order, provided that any such application is made on 7 days notice to the Appellants Solicitors.
