Three cost models are set out. They have been provided by a City firm of solicitors, who are regularly engaged in heavy commercial litigation. The solicitors have produced these models with the aid of the "costs estimator" software which they regularly use to predict likely disclosure costs. There are many variables, as can be seen from the tables. In summary, the first table in each example produces a typical cost of putting the electronic documents into an electronic database. The second table gives a typical cost for putting hard copy documents into electronic format. It does not include the cost of putting them onto the database which would be a small additional cost. The third table estimates the cost of a "linear review". This assumes that each document on the database is read and reviewed by a lawyer. This cost would in practice be considerably reduced by the use of electronic review tools, otherwise known as an "analytical review" such as concept searches, duplicate technology etc. The final reduced cost would depend on the tools used, the skills of the reviewers and, for example, the extent of the review agreed between the parties or ordered by the court. The models indicate that without the electronic review tools the cost of the linear review is likely to be disproportionate to the value of the dispute. It should be noted that the costs given do not include the initial cost of finding out where the documents are and collecting them. The "small", "medium" and "huge" headings represent the approach of the solicitors concerned. The huge volume example would be very rare but has been experienced by that firm.
