A Board

The Judicial College Board was formed on 1st April 2011. It is the governing body of the College. It sets the overall strategy for the College, agrees business plans and oversees the delivery of training within the budget allocated to the College.

Keith Baldwin advised the Board as a non-executive director until July 2011.

The first task of the Board was to agreed its <u>Strategy for 2011-14</u>.

A list of the courses and seminars which took place during the year for courts is contained in Annex 1.

B Tribunals

In line with the new governance arrangements for the Judicial College, the Tribunals Committee met for the first time in February 2012 and agreed its terms of reference.

The Senior President of Tribunals has statutory responsibility for the training of judges and other members of tribunals pursuant to the Tribunals, Courts and Enforcement Act 2007. His duties in relation to judicial training also extend to judges and other members of tribunals in reserved tribunals across the

UK. The Committee oversees Tribunals judicial training for those tribunals and takes account of the interests of devolved Tribunals and those Tribunals transfering into HMCTS.

The Tribunals Committee replaced the previous Judicial Studies Board ('JSB') Tribunals Committee and the Tribunals Judicial Training Group. The final tasks of the JSB Tribunals Committee had been to discuss and agree proposals for development of the College and the future governance structure and the response to the consultation on the College strategy.

Secretariat support for the new Tribunals Committee and administrative support for training in the Mental Health, Immigration and Asylum and Social Security and Child Support Tribunals (SSCS) are provided by College staff in London, Glasgow and Loughborough.

Discussions have continued with HMCTS/MoJ about funding from other Government departments for judicial training in the Employment Tribunal (ET) and SSCS where policy initiatives and new legislation will impact on the work of those tribunals.

Arrangements were put in place for the transfer of judicial training and associated funds from the Residential Property Tribunal Service (which became part of HMCTS in July 2011) into the College from 1 April 2012.

Courses

In the financial year 2011-12, the College delivered 55 residential courses and 330 non-residential courses (including evening meetings) to judicial office holders in tribunals. This equates to the provision of over 13,000 training days to individual office holders. The great majority of training provided for tribunal judges and members is delivered within individual jurisdictions, in line with the requirements of Chamber Presidents.

While there are a variety of methodologies and at present no College-wide approach, this will change once a cross jurisdictional evaluation strategy and a common training feedback form has been fully implemented. This will build in part on work started by a working group of the Tribunals Judicial Training Group to consider the standardisation of evaluation across tribunals.

The previous JSB Tribunals Committee considered the future of its multi-jurisdiction residential judgecraft courses and agreed to offer places to the courts judiciary in order to assess how the material might suit multi jurisdictional events. The first course to include courts judges was the Advanced Judicial Skills course in November 2011. Since then the Judicial College has established its forward looking strategy which includes piloting various approaches to common training for all judicial office holders in the skills and social context of judging.

C Courts

In line with the new governance arrangements for the Judicial College, the Courts Committee met for the first time on 27 January 2012 and agreed their terms of reference under the new governance structure.

The Courts Committee is responsible for the development and delivery of training for the Courts Judiciary in England and Wales, including magistrates and legal advisers where training is delivered in partnership with HMCTS through a network of trainers, including legal advisers, justices' clerks and magistrates, trained by the Judicial College. The Committee will also establish and keep under review the necessary governance arrangements for the delivery of training for the Magistracy and legal advisers

The Courts Committee replaced the previous JSB Judicial Training Committee and Magistrates Committee, along with the planning groups reporting to them. The final tasks of those committees had been to discuss and agree proposals for development of the College and the future governance structure and the response to the consultation on the College strategy.

Courses

49 courses were delivered for the courts judiciary and a total of 2664 delegates attended. A list of those courses is included at Annex 1.

The content and lay out for the third Courts Judiciary Prospectus for 2012/13 was finalised and contains 37 seminars to select from. The programme for 2013-14 was put in hand; the fourth prospectus will be published in October 2012.

The College also produces a range of supplementary training materials for the courts judiciary, which included:

- A paper by Professor Ormerod on the Bribery Act which has been placed on the training website.
- framework directions for the jury by Lord Justice Pitchford on both diminished responsibility and loss of control, based on the discussions from the seminars on the new partial defences to murder, subsequently included in the first revision of the Bench Book (Directing the Jury) and will be issued as a supplement.
- A Companion to the Bench Book (Directing the Jury) by Judges Tonking & Wait.
- A Family Courts reporting guide, published at the end of July 2011.
- 25 e-letters issued during this period.: 10 crime, 10 family and five civil.

D Magistrates

As mentioned above, in line with the new governance arrangements for the Judicial College, the responsibilities of the Magisterial Committee have now merged with those of the new Courts' Committee. One of the final decisions made by the Magisterial Committee was to reduce the sub-committees from four to two, namely a Criminal Sub-Committee and a Family Sub-Committee and these two sub committees will continue to report to the Courts Committee.

Courses Whilst some courses such as Train the Trainers and Bench Chairmen are delivered directly by the Judicial College staff, in most cases the College prepares training materials for local delivery. 23 courses were delivered directly by the Judicial College for magistrates and legal advisers and a total of 215 delegates attended. A list of those courses is included at Annex 1. Training for DJ(MC)s and DDJ(MC)s are also included in that Annex.

Projects All planned courses and projects have been delivered to time and budget. Savings have ben achieved where possible by using training venues within the departmental estate, using less colour printing and using teleconferencing for meetings. The key priority in this period has been 'Stop Delaying Justice', a campaign that aims to reduce the number of adjournments. This joint judicial project – crafted with the support of the Senior Presiding Judge, the Chief Magistrate, the Justices' Clerks Society, the Magistrates' Association and the National Bench Chairmen's Forum also has the support of HMCTS, the Criminal Procedure Rules Committee, the CPS and defence lawyers. A DVD was prepared and the first 'Train the Trainers' session took place in September 2011. The DVD was funded by the Judicial College but made by the Magistrates' Association using a script drafted by DJs(MC). Pooled resources were used to fund all travel and subsistence for local delivery to 10,000 participants and trainers in magistrates' courts between October and December 2011. The training materials have been widely used across the criminal justice system, accessed through the College's tutor website.

Magistrates' Area Training Committees (MATCs) Following receipt and review of the *MATC Annual Reports for Magistrate Training* and the *HMCTS Area Annual Reports for Legal Adviser Training* for 2010-11, the Training Advice Team drafted national summary reports for both magistrate and legal adviser training.

The improved and shorter national summary reports focus on the quality, provision and effectiveness of the training delivered to magistrates and legal advisers in 2010-11, highlighting key successes, challenges overcome and issues for consideration. These reports were provided for the Lord Chief Justice and the Magisterial Committee in March 2012, before it merged with the new <u>Courts' Committee</u>.

The positive feedback included in several of these Annual Reports reinforces that MATC and HMCTS training colleagues value the support and guidance provided through the College.

Publications The Family Proceeding Court Bench Book has been updated, as have training materials for courses in 'Family Consolidation', 'Training and Development Committees', 'New Members' and 'Legal Adviser Family Induction'. A guidance note has been produced on the Family Proceeding Rules 2010.

A full review of the cross-bench appraisal process was conducted, eliciting over 500 responses from a cross-section of users. The results of the review will inform the forthcoming update of the Training Development Committee and Good Practice Guidance issued by the College.

The College has expanded its support to HMCTS regions by providing dedicated web space for distance learning. In the case of London's Western clerkship this has allowed over 300 magistrates to complete their assault sentencing guideline training online, with 75 per cent of those completing the training indicating that they felt the stated aims and objectives had been fully met.

E Senior Judiciary

There have been 40 bookings made by High Court judges for the prospectus seminars running in 2012/13, with nine bookings for civil, 16 for criminal and 15 for family seminars. A number of Court of Appeal judges also attend the family seminar.

Six after court seminars took place during the year - on the Equality Act, e-disclosure, expert evidence and contempt of court. The College also supported an event for 40 Court of Appeal judges.

F Diversity & Development

Under the College's new governance arrangements, the Diversity & Development Committee met for the first time in March 2012. The Committee has subsumed the work of the Equal Treatment Advisory Committee (ETAC) which met for the last time in the same month. One of the final tasks of that Committee was to discuss and agree proposals for development of the College and the future governance structure and the response to the consultation on the College strategy. It had also assisted the Judicial Office with the development of guidance for judges on the Public Equality Duty (Equality Act 2010).

The Diversity & Development Committee works together with the Courts Committee and the Tribunals Committee to implement the College Strategy, to promote the development of common training programmes as appropriate (particularly training in judicial skills, training the trainers, leadership and management training) improving course design and evaluation, dissemination of best practice and training in the principles of diversity and fair treatment.

A Project Board was established to take forward proposals for the future timely updating of the Equal Treatment Bench Book. The Project Board has commissioned a survey of judicial office holders to ascertain their requirements regarding diversity and fair treatment issues.

Evaluation and training advice A summary of the post course evaluation information is available at Annex 1. Many tribunals will also have analysed feedback and evaluated their courses but at present there is no ability for the college to compare and collate the full range of feedback. Work has taken place on developing a cross jurisdictional evaluation strategy and a common training feedback form which will enable cross-College comparisons in future.

The evaluation of courses allows the College to identify what has worked well and the lessons to be learned for future courses. This is been reported to the course director and the relevant director of training. Work also continues with Magistrates Area Training Committees (MATC) and HMCTS training colleagues to ensure the quality and effectiveness of magistrate and legal adviser training across England and Wales.

The College offered advice and support on the design and delivery of Judicial College seminars across all jurisdictions and provided verbal and written feedback to course directors, designed to support improvement of the delivery and design of training courses.

G International

The International Committee reports on international training issues for the judiciary to the Judicial College Board. It enables the College to participate in appropriate judicial training projects which strengthen judicial independence and reinforce the judiciary as a key institution of democratic governance within the UK, across Europe and Internationally. There is a steady increase in the number of requests for meetings with judicial delegations and requests for assistance. The College continues to do its best to meet these.

H Looking ahead

Civil costs training Plans have been taking shape for a programme of training on costs in early 2013 for all salaried judges following the proposals in Lord Justice Jackson's report.

Family Justice Reforms Detailed discussions have taken place with plans well advanced to roll out training on the Family Justice Reforms (David Norgrove's report) in the spring of 2013. Mr Justice Ryder has been appointed by the President of the Family Division to oversee these arrangements.

Learning management System (LMS)

Under paragraph 32 of its Strategy, the Judicial College has undertaken to: 'develop and maintain a learning management system (LMS) which will be easily accessible and simple to use.' The LMS can be thought of as a virtual college, comprising different jurisdiction-specific areas, which contain .seminar materials, e-learning programmes and a library of supplementary materials. The final business requirements document and design for the LMS has been approved and work continues on populating the LMS with the aim of launching it in early 2013.

H Judicial Appointments

The Judicial College Board was formed on 1st April 2011. Some members of the Tribunals and Magisterial Committees and courts tutor team members across the board whose appointment term was due to end in 2011 have been extended to March 2012 or until the lower level governance strategy was agreed. Judge Picton has been appointed as course director (designate) for Serious Sexual Offences Seminars
